## REPORT OF THE PRESIDENT FOR THE YEAR ENDING DECEMBER 2003

This Report covers the activities of the Corporate Law Teachers Association (CLTA) for the year ending December 2003.

## **Executive Committee of the CLTA in 2003**

The CLTA constitution in clause 4(b) provides that the Executive Committee of the Association shall be comprised of a President, Secretary, Treasurer, the immediately preceding past President and four other members. Clause 6(d) provides that, in addition, the Executive Committee may co-opt up to three additional members to form part of the Executive Committee.

John Nelson of the Institute of Chartered Secretaries also participated in all meetings of the Executive Committee during the year.

Members will be aware of the tragic death of Michael Whincop during the year. Michael's commitment and contribution to corporate law teaching and scholarship was remarkable, as is evident in the many emails that I received expressing condolences and sadness on the news of his death. On behalf of the CLTA I wrote to his family, and I now pass on their thanks for the kind wishes of the CLTA membership.

The Executive Committee met (by teleconference) on four occasions during the year: 5 February, 2 September, 21 October, 2 December.

## 2003 CLTA conference

As members will be aware, unfortunately the 2003 CLTA conference, due to be held at the University of Auckland, was cancelled because of insufficient registrations. Much of the Executive's attention this year has been directed towards identifying the

reasons for this and seeking to ensure the success of future conferences. The Executive initiated a short email survey of members to gauge opinions about the timing and location of future conferences (and related matters). 25% of members responded to this email survey. The responses showed that the timing of the conference (with February as the highest preference) and the costs of travel were the two most important factors in members' decisions about attending.

## 2004 CLTA conference

The 2004 CLTA annual conference is being hosted by the Centre for Commercial Law at the Faculty of Law, Australian National University on 8-10 February 2004. The theme of the conference is "Regulating Corporations". The conference program, registration and accommodation details, and other information are available on the CLTA website.

## **Future CLTA conferences**

The venue of the 2005 CLTA will be discussed at the CLTA AGM and the meeting of the Executive Committee to be held at the ANU conference. The Faculty of Law, University of Sydney has expressed an interest in hosting the conference.

The Association seeks to ensure that the Executive Committee of the CLTA has a geographic spread of members as well as members representing different institutions.
